

Note:


- To start the service your facility should have a MOHAP approved facility license.
- If you have a valid license you can start this service nut only if there are less than 60 days left for your license to expire OR your license has expired, but for not more than 180 days since expiry.
- The system will prevent you from starting this service if there are staff members with expired licenses (Their licenses will need to be renewed or cancelled).




4 When you start the service, you will see your facility's license details.


An application fee of 100 AED may be applicable for Private Sector facilities.

Click "Proceed to Payment" to continue or submit the application.




9 On successful payment or submission, you are shown a detailed application status page with pertinent details about the application.




10 Click "Go to Dashboard" to find the application details from your dashboard

 - Expired: Applications that expired while awaiting action from the applicant.


